Remember that the leaves that fall onto your property from common ground trees cannot be blown or raked into the common ground per Chesterfield ordinance.

### CHESTERFIELD ORDINANCE REMINDERS

\*It is a Code violation to dump anything in our common ground. Specifically, it is a criminal offense to dump anything in the common ground MSD creeks.

\*Holiday lights are permissible from November 15 through January 25.

\*There is no dumping of gravel, mulch, etc. in the street by homeowners, contractors or material suppliers. Please use your driveway.

\*If you are replacing your driveway to include the sidewalk and/or the apron, the homeowner must first receive a Special Use Permit from the Chesterfield Dept. Of Public Works. 636.537.4762

\*If you or your contractor is having any type of dumpster (roll off container) including one from Republic Services placed in your driveway, the homeowner must first obtain approval by submitting a Municipal Zoning Application (MZA) to the Dept. of Planning. 636.537.4733. There is a 30 day limit for the dumpster to be in your driveway.

\*Homeowners may plant a tree in the Right of Way (area between the sidewalk and the street) but must get a Special Use Permit (SUP) from the City and choose a tree from the approved list of street trees. Contact Public Works at 636.537.4762. \*Tree and bush debris may be on a lot no longer than 14 days.

\*Pets must be leashed and please pick up after them.

\*<u>Any</u> cans used for trash, recycling or yard waste can only be visible from 5 pm the day before pickup and midnight the day of pickup. Let's not leave our cans out until Wednesday or Friday.
